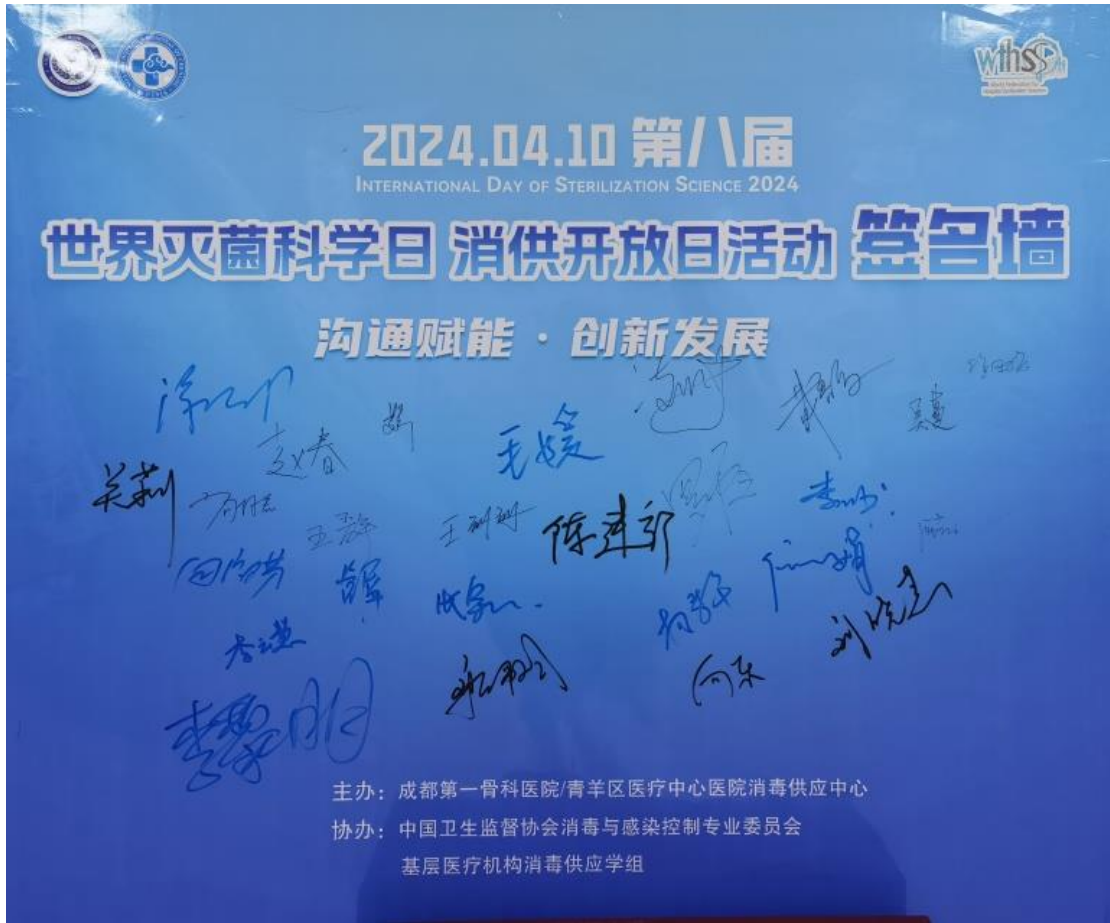

Site visit

Under the guidance of Tang Honghua, the head nurse of the CSSD, the participants visited the work areas in an orderly manner.



In the Decontamination Area, team leader Zhang Yuhong introduced the building layout, equipment and facilities, and the returning, classification, cleaning, disinfection, and drying processes of reusable instruments. The focus was on the on-site demonstration of the orthopedic power instruments by Wang Lisha.



In the Inspection, Packaging and Sterilization Area, team leader Li Liming introduced the regional environment and work flow as well as the key aspects of cleaning quality inspection during assembly. Nurse Bai Jinli gave an on-site explanation and demonstration on how to determine a qualified sterilization package. The interactive quiz would reward winners with a

small gift (the Xixiang Shicheng gift bag contains the hospital's special preparations: Shangtong Hot Compress Ling, Dampness Removing Tea, Qi-Invigorating Spleen Tea, Liver-Soothing and Qi-Regulating Tea).



In the Sterile Storage Area, team leader Xiang Dong introduced the layout and distribution process, the storage requirements for sterilization packages, the monitoring requirements and working principles of incubators.
